

REGULATIONS AND RESPONSIBILITIES OF THE RESERVATION MANAGER AND CUSTOMERS

CREDIT CARD ON FILE: The reservation manager must inform all occupants of the unit of the regulations and responsibilities listed below. He accepts responsibility for any lack of inventory, lost key, property damage, and/or unreasonable condition of the accommodation unit following the stay. He authorizes Le Domaine des Montagnais to use the credit card on file to bill the occupants if he fails to respect the rules mentioned above.

PETS: In some chalets, dogs and cats weighing less than 10 pounds are accepted. The additional costs are \$ 20 / night.

In the event of breakage or damage to furniture and the building and additional maintenance caused by the animal (excrement inside and outside, hair, unpleasant odors, etc.), all costs related to this must be borne. If, however, a pet is present or has been present during the stay without the Domaine des Montagnais having been informed, a fee of \$250 will be charged. Management always reserves the right to refuse access to a pet without reimbursement of living expenses.

MAXIMUM CAPACITY: The maximum capacity of the accommodation unit must be respected. A fee of \$ 50 per additional person will be charged.

NON-SMOKING ACCOMMODATION: All accommodation units are non-smoking. Fees of \$400 for a suite and rooms and fees of \$ 600 for a chalet apply in the event of non-compliance.

INTERIOR FIREPLACE: For chalets with a propane gas fireplace, use ONLY the wall thermostat. For reasons of safety, the fireplace and its components (valves, pilot, etc.) must not be touched.

EXTERIOR FIREPLACE: For chalets equipped with an outdoor fireplace, wood is on sale at the reception office. The surrounding vegetation must be respected by not breaking tree branches to fuel the fire. Fees of \$ 250 apply in the event of non-compliance. From November to April, It is strictly forbidden to remove the packaging that covers patio furniture. Fees will be charged for repacking.

RESPECT OF OTHER VISITORS: The curfew is in effect from 11 p.m. to 8 a.m. At all times, any excessive noise that disturbs the tranquility of visitors could result in expulsion without refund. Fees will be charged to cover the costs of control and / or compensation to other visitors.

OUTDOOR POOL: It is accessible from June 24 until Labor Day. Only Domaine des Montagnais customers have access to these facilities. Glass containers, dives, running, pets and excessive noise are forbidden. Everyone under the age of 16 must be accompanied by an adult.

ACTIVITIES AND PLAYGROUND: Recreational equipment such as cross-country skis, snowshoes, can be used to practice activities unstructured on the site. Hiking can be done in the undergrowth, but no path is marked and maintained. People aged 16 and under must be under the supervision of an adult.

STATE OF CLEANLINESS: The person responsible for the reservation is responsible for returning the chalet to an acceptable state of cleanliness. Surplus fees cleaning fees will be charged at the rate of \$ 30 / hr.

WASTE: On departure, trash and recycling must be placed in their respective containers installed between chalets # 202 and # 204 on the Chemin de la Forêt-Enchantée. A fee of \$ 50 applies in the event of non-compliance.

ARRIVAL AND DEPARTURE TIME: The arrival time is at 4 p.m. and the departure time is no later than 11 a.m. Penalty of \$ 40 / h additional.

Each client is fully responsible for their actions and their experience as well as their personal effects. In the event of accidents, theft, etc., le Domaine cannot be held responsible for it.
